What to do when AN INCIDENT OCCURS

Do not accept liability or enter into detailed discussions with the third party



Notify the police of any injuries, criminal allegations or if you cannot exchange details



Swap details with the third party and obtain as many witnesses as possible



Draw diagrams and take photos if it is safe to do so



Note the date, time and location of the incident



Notify your insurer or broker's claims team



Here's how to REPORT AN INCIDENT

Our third party claims line is open 24 hours a day,
7 days a week.

They'll take the details of the incident and will pass
an initial notification to your insurer's claims team.
